## PRIVY COUNCIL GENERAL (AMENDMENT) ORDER 2017

### NO. 1/2017

#### 1. Short Title and Interpretation

- (1) This Order may be cited as The Privy Council General (Amendment) Order 2017.
- (2) The Privy Council General Order 2011 (Order No. 1 of 2011), as amended, shall be referred to as the Principal Order.

#### 2. Clause Amended

Clause 8(1)(f) of the Principal Order is amended by adding after "Schedule 3" the words "or Schedule 4".

#### 3. Schedules Amended

The Schedules are amended by adding an additional Schedule, namely Schedule 4, in terms as follows :-

### "SCHEDULE 4

#### [Clause 8(1)]

#### ACT OF SERJEANTY: APPOINTMENT AS A LAW LORD

WE, TUPOU VI, by the Grace of God, of Tonga, King :

CONSIDERING that it is Our Prerogative to appoint as Law Lords persons versed in the law, this being a title of honour and an honourable distinction, which power has been conferred on Us by Clause 44 of the Act of Constitution of the Kingdom of Tonga and Clause 8(1)(f) of the Privy Council General Order 2011 (as amended):

NOW THEREFORE WE REPOSING CONFIDENCE in our trusty, learned and well beloved ....., being Counsel learned in the law :

DO HEREBY by this Act of Serjeanty appoint the aforementioned  
.....to be one of Our LAWLORDS.
