## CUSTOMS DUTY (AMENDMENT) ORDER 2016

### CUSTOMS ACT 2007

---

*IN EXERCISE of the powers conferred by section 3 of the Customs Act 2007, the Minister responsible for revenue and customs, with the approval of Cabinet, makes the following Order -*

---

- 1 This Order may be cited as the Customs Duty (Amendment) Order 2016.
- 2 The Customs Duty Order 2008, as amended, imposing customs duty on goods effective from 1 February 2008 and published in the Government Gazette Supplement Extraordinary on 21 January 2008 shall be referred to as the Principal Order.
- 3 The Principal Order is amended by inserting the following new national tariff splits and their corresponding import duty rates:
